Practical COVID update for Fall 2023: Four practical things family physicians should know

- Develop and apply an effective management strategy for NAFLD/NASH patients that incorporates the most suitable lifestyle interventions and pharmaceutical therapies while considering patient preferences and potential comorbidities.

Evolving Evidence on Human Papillomavirus Vaccination: Expert Updates on Head and Neck Cancer

- Recognize the benefits of interdisciplinary collaboration in promoting HPV vaccination to reduce the risk of HPV-related cancers.
